Resolution 2011-17

Pursuant to the provisions of K.S.A. 65-3410, BE IT RESOLVED, this 26th day of September 2011, by the Board of County Commissioners of Lincoln County, Kansas, that the delinquent fees set forth in 'Exhibit A' as confirmed shall constitute assessments against the respective parcels of land and are a lien on the property for the amount of such delinquent fees. The delinquent fees shall be collected at the same time and in the same manner as ordinary county ad valorem property taxes are collected and shall be subject to the same penalties and the same procedure and sale in case of delinquency as provided for such taxes. All laws applicable to the levy, collection and enforcement of county ad valorem property taxes shall be applicable to such assessment.
