## COMMISSIONER PROCEEDINGS

January 7, 2008

Resolution 2008-03:

Call to Order: The regular meeting of the Lincoln County Board of Commissioners was held in the

commission meeting room of the courthouse Monday, January 7, 2008. Chairman Al Joe Wallace called the meeting to order at 10:00 a.m. with Vice-Chairman Terry Finch

and Member Steve Errebo present. County Clerk Dawn Harlow was in attendance.

Visitors: Others present for portions of the meeting: Wendy Gronau, Leann Bishop, Russ Black,

Les Richards, Michel O'Hare, Debora Zachgo, Richard Schultz, Chris Behrens, Jyll

Phillips, Roger Suelter and Aaron Suelter.

Ambulance Service: Ambulance Service Director Wendy Gronau presented price estimates to purchase an

electronic stethoscope for each ambulance. The board approved the purchase. Gronau discussed the series of articles ran by the Salina Journal concerning ambulance services in the State of Kansas. Gronau provided statistical information on ambulance runs for 2006 and 2007 as well as 2007 education hours completed by Ambulance Service personnel in 2007. Gronau reported that Michael Fosha has completed his first year of service and requested the customary salary increase. Terry Finch moved to grant Michael Fosha a twenty-five cent per hour merit increase for the completion of the first year of service, effective December 26, 2007, seconded by Steve Errebo. Motion carried. Gronau related that she is planning a community wide CPR class on February

5; and discussed lighting problems with the ambulances.

Treasurer: Deputy Treasurer Leann Bishop presented three annual resolutions for the board's

the following Lincoln County banks as depositories of all moneys of Lincoln County, Kansas for the year 2008: Bank of Tescott, Midwest Community Bank – Beverly, Midwest Community Bank – Lincoln, Thunder Bank - Sylvan Grove, Farmway Credit

Union - Lincoln, and State Municipal Investment Pool-State of Kansas; Resolution

Resolution 2008-02: 2008-02, authorizing the County Treasurer to develop and implement a cash

management and investment program for the handling of moneys in the custody of Lincoln County, Kansas for the year 2008; and Resolution 2008-03, allowing the

County Treasurer to invest idle funds as seen feasible in Lincoln County banks or

investments, seconded by Terry Finch. Motion carried.

Law Enforcement: Sheriff Russ Black and Undersheriff Les Richards reported on Sheriff's Department

activities. The board discussed the proposed political activity policy.

Highway Department: Assistant Road Supervisor Michel O'Hare provided employee evaluations completed.

O'Hare reported on highway department projects; and discussed permitting problems with fuel tanks at outlying shops, noting that KDHE will not permit the tanks unless State Fire Marshal requirements are met. O'Hare presented several options to meet the requirements, after discussion the board requested O'Hare obtain price quotations to replace the outlying shop tanks with properly vented double wall tanks. Al Joe Wallace relayed information concerning a county leased gravel pit. Wallace forwarded a request

from the Milo Cemetery board requesting use of the County's tree clipper. The board approved the request with the condition that a County employee must volunteer to operate the equipment.

Recess: The chairman recessed the meeting for lunch at 12:07 p.m.

Reconvene: The chairman reconvened the meeting to regular session at 1:00 p.m.

immediately, seconded by Terry Finch. Motion carried.
