commission meeting room of the courthouse Monday, August 24, 2015. Chairman Gerald Huehl called the meeting to order at 8:00 a.m. with Vice-Chairman Al Joe Wallace and Member Terry Finch present. County Clerk Dawn Harlow was in

attendance.

Courthouse Review: Jacob Hurla, 360 Energy Engineers presented information on the company and services

provided to taxing entities through the State, by analyzing several items including energy usage and building construction, to propose modifications that will improve energy efficiency. Hurla related that there is no charge for a site walkthrough and review. The board approved allowing the company to complete a site walkthrough of

the courthouse, with no guarantee that they will move forward with a project.

Highway Department: Director of Public Works Michel O'Hare reported on highway department projects.

O'Hare presented utility permit agreements for the board's approval. Al Joe Wallace moved to enter into two utility permit agreements with Post Rock Rural Water District #1, seconded by Terry Finch. Motion carried. O'Hare presented three real estate acquisition forms for the board to approve. Al Joe Wallace moved to approve the following acquisitions of Real Estate for the 53C-OS-33, Rattlesnake Creek Bridge, bridge replacement project: purchasing permanent road right-of-way from Gary L. Pepper & Beverly J. Pepper in the amount of \$69.60; purchasing permanent road right-of-way from Dwight L Daniels & Delores G Daniels, in the amount of \$3,914.40; and purchasing permanent road right-of-way from Charlene Watson Life Estate, in the amount of \$607.20, seconded by Terry Finch. Motion carried O'Hare requested approval to attend a multi-state meeting September 23-25, noting that the Kansas Highway Officials Association will pay for registration fees, county will be responsible

for all other expenses. The board approved the request.

Nursing Home: Christen Robinson, Lincoln Park Manor, discussed a letter received by both the county

and herself, from a resident's family member. The board requested that Robinson invite the family member to attend a commission meeting with her. Robinson reviewed information received at a recent conference in regards to inspections, and that she visited with potential vendors in regards to flooring, noting that one company offered to supply materials for free to complete 400 sq feet, with the only cost being labor to

install.

meeting as presented, seconded by Al Joe Wallace. Motion carried.

Human Resources: Human Resource Officer Zachgo discussed the Ambulance Service Director position.
