Call to Order: The regular meeting of the Lincoln County Board of Commissioners was held in the

> commission meeting room of the courthouse Monday, January 5, 2009. Chairman Terry Finch called the meeting to order at 10:00 a.m. with Vice-Chairman Steve Errebo and Member Al Joe Wallace present. County Clerk Dawn Harlow was in attendance.

Audit Contract Al Joe Wallace moved to approve an audit contract between Lincoln County and Pierce, Approved: Faris & Co, Chartered, to provide audit services for the fiscal year ended December 31,

2008, seconded by Steve Errebo. Motion carried.

**Public Building** Mitch Obermueller, Bank of Tescott, answered the board's questions on the public Commission:

County Treasurer: County Treasurer Joyce Walker presented three annual resolutions for the board's

State of Kansas, seconded by Al Joe Wallace. Motion carried.

Nursing Home: Nursing Home Administrator Christen Robinson presented bids to replace the water

softener in the assisted living facility. The board tabled a decision until the January 12,

2009 regular meeting.

Highway Department: Road Supervisor Larry Meitler reported on highway department projects and equipment

repairs. Meitler and O'Hare provided ideas for future road repair projects and asked for the board's opinions on specific areas. Meitler presented bids received to purchase a new backhoe; recommending that the board not purchase the lowest bid backhoe, due to safety concerns with certain aspects of the equipment. After discussion, Steve Errebo moved to purchase a John Deere Model 310SJ Backhoe from Murphy Tractor & Equipment Co. in the amount of \$62,500.00, seconded by Al Joe Wallace. Motion carried. O'Hare provided the average cost to replace vandalized and/or destroyed road signs. O'Hare inquired if the board wanted to pass a resolution guaranteeing highway department employees a set amount of hours when employees are called back to work during the evenings and weekends. Commissioners indicated that they would be in

favor of guaranteeing hourly employees to be paid for four hours of time, when called out for work requiring less than four hours to complete and guaranteeing eight hours of time for work requiring more than four hours to complete. No formal action on guaranteeing wages was approved this date. The board discussed bridge project management.

Recess: The chairman recessed the meeting for lunch at 12:22 p.m.

Reconvene: The chairman reconvened the meeting to regular session at 1:00 p.m.

**Executive Session:** Steve Errebo moved to recess into executive session for twenty minutes from 1:04 p.m.

approved the request.

Tax Abatement: Al Joe Wallace moved to allow tax abatement 2008-16 in the amount of \$144.97,

seconded by Steve Errebo. Motion carried.
