County Wide Health Living Master Plan:

Kelly Larson introduced members of the County Wide Healthy Living Master Plan Committee and presented the Lincoln County, Kansas Healthy Living Master Plan requesting that the board adopt the plan. Larson provided history on the committee and plan formulation beginning in 2015 through current. The committee answered questions regarding the plan and specific projects. Larson related the Lincoln Ave Bridge and McReynolds Mill Park as potential projects that would need assistance from the county. Alexis Pflugh moved to approve the Lincoln County, Kansas Healthy Living Master Plan, for the purpose of supporting citizen initiated community projects, to be funded by independent action on each project in attempt to complete this plan, with no commitment of future county action or funding, seconded by Randy Lohmann. Motion

carried.

City of Sylvan Grove: City of Sylvan Grove Representatives Jennifer Huehl and Stephen Boor inquired about the status

of purchasing one of the County's motor graders and funding options.

**Nursing Home:** 

Commissioner Lohmann related that he is drafting correspondence to John Grace regarding the nursing home which will include the following topics: rent; accounts payable; Appendix A of the lease, including specific responsibilities regarding maintenance; CHOW paperwork with the buyout option; current lease; and assisted living status.

**Public Comments:** 

The following comments from the public in attendance were received, which brought about lengthy discussions on each of the subject matters throughout the meeting: Jennifer Huehl inquired about the board's intention regarding a bridge on Hawk Rd; John Gabelmann – why has the county not sued the nursing home operator for the past rent; Larry Dohe - disagrees with how the windfarm money is saved, does not like how the money given to the schools is based upon the location of the wind towers, and does not believe that county employees are taxing citizens equitably; David Gerstmann - has the board looked at statutes regarding Home for the Aged mill levy limits, requested that county post tax history on the website so that citizens can search historical information without having to file an open records request, and appointing a citizens advisory board for the highway department; Brandon Cochran - reported that he had resigned Thursday, May 23, 2019 at 10:00 a.m. as Interim Ambulance Service Director, the board will need to appoint a new Interim Director by Wednesday, May 29, the following licenses will need addressed: Board of Pharmacy License, DEA License and CLIA License. The board informed Cochran that the Board of Commissioners has been listed as Director on the ambulance license. (Dawn Harlow disclaimer: comments were not necessarily made in the order listed, an attempt was made to record subject matters that were directed to the board; attendees participated in conversations regarding the stated subject matters, however I do not make a practice of recording conversations)
