Call to Order: The regular meeting of the Lincoln County Board of Commissioners was held in the commission

meeting room of the courthouse Monday, December 31, 2018. Chairman Terry Finch called the meeting to order at 10:00 a.m. with Vice-Chairman Alexis Pflugh and Member Al Joe Wallace

present. County Clerk Dawn Harlow was in attendance.

Minutes approved: Terry Finch moved to approve the minutes of the December 24, 2018 regular meeting as

corrected, seconded by Al Joe Wallace. Motion carried.

Budget Hearing: Chairman Finch convened the scheduled budget hearing at 10:17 a.m., for the purpose of hearing and answering objections of taxpayers relating to the proposed amended use of

budgeted funds. The chairman adjourned the budget hearing at 10:30 a.m. and convened the meeting to regular session. Alexis Pflugh moved to approve the amended budget for 2018, seconded by Terry Finch. Motion carried. Human Resources: Human Resource Officer Sionia Case provided quotes to advertise for the ambulance service

director and presented job descriptions previously requested by the board. The board reviewed the job descriptions and discussed changes made between previous job descriptions and the 2018 approved job description. Case related that the highway department would like to consider the internship program with the high school for secretarial services. Case will contact the school to get additional details. Case related that she has received a departments employee evaluations

and inquired if the board would like to review. The board will review at a later date.

Requests: David Gerstmann requested that the board consider the following resolutions for 2019: request

formal training from the Kansas Attorney General regarding the Kansas Open Meetings Act, and related that the board was in violation of the open meetings act during the December 24 regular meeting when the board did not state a subject when entering into executive session; that the commissioners would prohibit the highway department from entering private property, or utilizing county vehicles or labor without obtaining prior written consent from the landowner; and that the board would stop mileage reimbursements to commissioners to attend weekly

commission meetings.

Ambulance Service: Ambulance Service employee Brandon Cochran inquired about plans for leadership at the

department since the resignation of Bret Kingan as Interim Ambulance Director. Cochran and ambulance service Shiloh Florence answered questions regarding what the director was responsible for and what aspects are being completed by employees currently. Cochran related that he would be willing to act as the interim director until the position is filled. The board requested Human Resource Officer Case to contact ambulance service staff to determine if any
