Call to Order: The regular meeting of the Lincoln County Board of Commissioners was held in the

commission meeting room of the courthouse Tuesday, December 30, 2008. Chairman Terry Finch called the meeting to order at 10:00 a.m. with Vice-Chairman Steve Errebo and Member Al Joe Wallace present. Debora Zachgo served as recording secretary in the absence of Clerk Harlow from 10:00 a.m. – 11:30 a.m. and from 2:00 p.m. – 3:35

p.m.

Visitors: Others present for portions of the meeting: Russ Black, Michel O'Hare, Lester

Richards, Cade Richards, Jennifer O'Hare, Stanley Walker, Rodney Job, Wendy

Gronau and Kathy Lupfer-Nielsen.

Law Enforcement: Sheriff Russ Black indicated the need for a new law enforcement building. Black

inquired about transferring money, as budgeted, from his 2008 budget to the Capital Improvement Fund to be earmarked for the purchase of new 800 MHz radios in late 2009. Black reported prisoner caused damage to the jail area has been repaired; and noted that one of the jail cells shower liner will need to be replaced. Black discussed future patrol car replacement; law enforcement activities; and inquired about cost of

living increases for 2009.

Highway Department: Assistant Road Supervisor Michel O'Hare reported on highway department projects.

Resolution 2008-22: Steve Errebo moved to approve and adopt Resolution 2008-22, pursuant to K.S.A. 12-110(d), transferring \$15,000.00 from the Lincoln County Ambulance Service 2008 budgeted funds into the Lincoln County Ambulance Service Capital Outlay Fund,

seconded by Al Joe Wallace. Motion carried
