Terry Finch inquired if the County had any rock available for use at the nursing home to cover fabric around the chillers. O'Hare related that the County had some rock available at the north lot. that O'Hare recalculate estimates to gravel the roads requested by Steve Schneider. Howe reported that crews are almost finished with OS 65; are graveling three miles of road on E Elk

Dr; and are working on a box bridge.
