meeting room of the courthouse Monday, June 18, 2018. Chairman Terry Finch called the meeting to order at 8:08 a.m. with Member Al Joe Wallace present and Vice-Chairman Alexis

Pflugh present via telephone. County Clerk Dawn Harlow was in attendance.

Minutes Approved: Al Joe Wallace moved to approve minutes of the June 11, 2018 regular meeting as presented,

seconded by Terry Finch. Motion carried.

USD 298 Request: USD 298 Superintendent Kathy Robertson and School Board President Monty Breneman

requested that the board consider distributing \$1.5 million of the Windpower Economic Benefit Funds to the school district to make capital improvements to the grade school and high school buildings and build a community storm shelter at the high school. Grade School Principal Steve Koch and Jr.-Sr. High School Principal Christi Walter provided information on

the capital improvements to their respective buildings.

USD 299 Request: USD 299 Superintendent Jude Stecklein and Board Member Marc Lovin requested that the

board consider distributing \$1.1 million of the Windpower Economic Benefit Funds to the school district to make capital improvements to the grade school and high school buildings and

build a storm shelter at the grade school.

Highway Department: Director of Public Works Michel O'Hare with Road and Bridge Supervisor Robert Howe and

Tanner Yost, Kirkham Michel reported of the following: that the Federal Fund Exchange Program will be changed back to the 90/10 split beginning next year; and held a meeting with the blade operators and none were interested in taking on supervisory responsibility while maintaining their current route. O'Hare related that the application for bridge replacement funding is now available and inquired which bridge the county should apply for. Yost related that he believes OS 107 has a better chance to be approved for funding as it has a lower sufficiency rating than OS 65, and that if the board would like to apply for funding for both bridges, the county will need to prioritize the projects. Howe provided an evaluation for Colton Panzer, relating that he has completed his first six months of employment and requested the customary salary increase. Al Joe Wallace moved to grant Colton Panzer a fifty cent per hour salary increase for the completion of the first six months of employment, effective May 26, 2018, seconded by Terry Finch. Motion carried. Yost related that the signage project is

complete.

Nursing Home: Eric Johnson, Campbell & Johnson PA, presented a change order request adding \$1,235.59,

which would replace the material used to cover the floor expansion joints. Al Joe Wallace moved to approve Change Order No. 7 in the amount of \$1,235.59, seconded by Terry Finch. Motion carried. Voting as follows: Finch – Aye; Wallace – Aye; Pflugh – Abstained. Johnson

requested that the board appoint a representative to attend the punch list walk through. Wallace related that Terry Finch had been appointed the board representative for the project.
