commission meeting room of the courthouse Wednesday, May 6, 2020. Chairman Randy Lohmann called the meeting to order at 10:03 a.m. with Vice-Chairman James Gabelmann and

Member Alexis Pflugh present. County Clerk Dawn Harlow was in attendance.

Visitors: Others present for portions of the meeting: Ladonna Reinert, Sarah Hageman, Leann Bishop,

Correspondence: Correspondence: Commissioner Lohmann provided a list that was received at the April 25,

2020 hospital board meeting of potential COVID-19 funding sources for the hospital; and a letter from County Attorney O'Hare notifying the submission for the KOMA complaint was

mailed.

Health Department: Health Nurse/Administrator Ladonna Reinert provided an update on COVID-19 and presented

the following: Governor's Plan to Reopen Kansas; recommendations in following Phase One of Governor Kelly's order requesting the board sign in support; mandatory 14 day quarantine travel areas required by the State; and the results of the business survey that was conducted in conjunction with Economic Development. budget request. Mosher requested that the County restore the funding that was cut for 2020 as the funding does not meeting the needs of Lincoln County residents and does not cover the

cost of delivering services in Lincoln County.
