## **COMMISSIONER PROCEEDINGS**

June 16, 2008

Call to Order: The regular meeting of the Lincoln County Board of Commissioners was held in the

commission meeting room of the courthouse Monday, June 16, 2008. Chairman Terry Finch called the meeting to order at 8:00 a.m. with Vice-Chairman Steve Errebo and

Member Al Joe Wallace present. County Clerk Dawn Harlow was in attendance.

Visitors: Others present for portions of the meeting: Joyce Walker, Wendy Gronau, Rod Rees,

Tami Kerth, Michel O'Hare, Larry Meitler, Art Wagoner, Carl Eyman and Dan Heina.

County Treasurer: County Treasurer Joyce Walker related that all employees who issue drivers licenses

must have a background check and be fingerprinted beginning January 1, 2009, noting that all employees have been fingerprinted. Walker discussed investment options for the Windpower Economic Benefit Fund. The board approved investing the PILOT payment received to date into a certificate of deposit. Walker discussed concerns over

the recent audit process and the air conditioning unit in the Treasurer's Office.

Ambulance Service: Ambulance Service Director Wendy Gronau and EMT I/D Rod Rees reported that the

ambulance service had been requested for an agency assist in Chapman and that a crew covered the Saturday day shift for the tornado damaged community. Gronau provided

an estimate of the cost to the ambulance service for providing the assistance.

Register of Deeds: Register of Deeds Tami Kerth presented the Register of Deeds Office's 2009 budget

request.

Highway Department: Road Supervisor Larry Meitler with Assistant Road Supervisor Michel O'Hare reported

on highway department projects. The group discussed a ditch maintenance project in Grant Township, Section 14. Commissioners forwarded areas of concern within their respective districts. The group discussed the bridge project 053C-4152-01, West Elkhorn Creek Bridge replacement project. O'Hare reported on the status of the following projects being completed by John Cashatt, Schwab-Eaton, P.A.: Bulk Fuel Facility Spill Prevention, Control and Countermeasure Plan; Survey of N 260<sup>th</sup> Rd; Landfill mapping; and N 280<sup>th</sup> Rd road slide. O'Hare provided cost information for alternative bridge structures being built by the Ellsworth County Highway Department.

O'Hare discussed future equipment needs.
