Property Acquisition: Commission Ray related that CVA had contacted him that the County was the successful bidder

for the property adjacent to the Westfall shop and that a packet would be mailed to the County.

County Clerk: Clerk Harlow requested that the chairman sign the 2023 budget allocations for the District Court

> and Conservation District. Clerk Harlow provided a copy of the invoice that will be mailed to the State of Kansas for reimbursement of the county's cost to prepare and mail the Revenue Neutral
