# 2006R-05 PRELIMINARY RESOLUTION AND NOTICE OF PROPOSED VACATION

On this 6th day of November, 2006, at a duly constituted and regular meeting of the Lincoln County Board of Commissioners, of Lincoln County, Kansas, all members of said board being present, the matter of a proposed vacation of certain roads located in Scott Township comes on for hearing before said board.

The Board, after due consideration, and after viewing certain roads described as follows:

#### Road 1:

That road beginning 1000 feet east of the southwest corner of Section 31 thence running northwesterly to the east-west half section line of Section 30 all in Township 10 Range 7, said right-of-way being 40 feet.

## Road 2:

That road beginning 1300 feet north of the southeast corner of Section 6 also being the southwest corner Section 5 thence north to half section line thence east on the half section line of Section 5 to the northeast corner of the southwest quarter all in Township 10 Range 7, said right-of-way being 40 feet.

## Road 3:

That road beginning at the southwest corner of the east half of the southeast quarter of Section 22 thence north on the half section line to the northwest corner of the east half of the southeast quarter thence northeasterly to south line of the north half of the northeast quarter of Section 22 in Township 10 Range 7, said right-of-way being 40 feet.

## Road 4:

That road beginning at the southwest corner of the northwest quarter of Section 26 also being the southeast corner of the northeast quarter of Section 27 thence east 1180 feet, also beginning at the southwest corner of the northwest quarter of Section 26 also being the southeast corner of the northeast quarter of Section 27 thence northeasterly to the north section line of Section 26 thence northeasterly to the north line of the south half of the southeast quarter of Section 23 thence east to the east section line of Section 23 all in Township 10 Range 7, said right-of-way being 40 feet.

#### Road 5:

That road beginning at the southwest corner of the northwest quarter of Section 24 thence east on the half section line to the east section line of Section 24 in Township 10 Range 7, said right-of-way being 40 feet.

## Road 6:

That road beginning at the northeast corner of Section 24 Township 10 Range 7 also being the northwest corner of Section 19 Township 10 Range 6 thence south on the section line to the southeast corner of the north half of Section 36 Township 10 Range 7 also being the southwest corner of the north half of Section 31 Township 10 Range 6, said right-of-way being 40 feet.

# Road 7:

That road beginning at the southeast corner of Section 25 also being the northeast corner of Section 36 thence west 2,630 feet in Township 10 Range 7, said right-of-way being 40 feet.

NOW THEREFORE, before entering a final order of vacation, the County Clerk is directed to cause a notice of said proposed vacation to be published as provided by K.S.A. 68-102 et seq., and that the board will make its final determination of such proposed vacation at a hearing during it regular meeting at the courthouse on November 27, 2006. The hearing will be held at 10:00 a.m.

All parties interested in said proceedings are advised to appear at said meeting at which time they will be heard.
