Health Department: Health Nurse/Administrator Ladonna Reinert presented a combined grant application

for the board's approval. Steve Errebo moved to approve the chairman signing the grant application for the following grant funds: State Formula, Family Planning, and Maternal & Child Health, seconded by Terry Finch. Motion carried. Reinert discussed funding cuts to various State grant funded programs and how the cuts will affect her

department.
