Correspondence:	Correspondence: a letter from Tracey Mann; and the Lincoln County Hospital Board of Trustees 2024 budget request.
Coroner Complaints:	The board discussed complaints received regarding a delay in death certificates being issued. In addition, individuals have asked why Lincoln County does not have an assistant coroner appointed. Cloud County Board of Commissioners is responsible for appointing the District Coroner, and the District Coroner is responsible for appointing assistant coroners. Commissioner Ray said he spoke with a Cloud County Commissioner to share the concerns and was told that Cloud County Commissioner had discussed the subject at their last board meeting.
District Court:	District Court Clerk Lisa Feldkamp provided a bid received to digitalize district court records, allowing the district court to destroy paper records and reduce the amount of weight stored on the third floor of the courthouse. Feldkamp inquired if the board would like her to budget a portion of the expense in her 2024 budget. The board approved including part of the cost in the upcoming budget year.
USD 112 Special Question:	Jane Dreiling discussed the August 1 Special Election asking voters whether USD 112 should be disorganized. Dreiling discussed potential negative impacts on taxpayers, students, staff, and surrounding school districts.
Payroll/Accounts Payable Approved:	Debora Smith moved to approve payroll in the amount of \$230,461.35, seconded by Darrell Oetting. Motion carried. Debora Smith moved to approve accounts payable in the amount of \$917,137.88, seconded by Darrell Oetting. Motion carried.
2024 Budget:	County Clerk Dawn Harlow inquired about 2024 budget amounts for appropriations made by the board. The board discussed the Noxious Weed Department staffing, solid waste disposal fees, and transportation bus allocations. The board requested that Clerk Harlow schedule Tony Lamia, Slechta Enterprises, on the agenda to complete the recycling center's six-month review.
