Call to Order: The regular meeting of the Lincoln County Board of Commissioners was held in the

commission meeting room of the courthouse Monday, August 2, 2010. Chairman Al Joe Wallace called the meeting to order at 8:00 a.m. with Member Steve Errebo present and Vice-Chairman Terry Finch absent. County Clerk Dawn Harlow was in attendance.

Member Arrives: Vice-Chairman Terry Finch arrived at 8:20 a.m.

County Treasurer: County Treasurer Joyce Walker discussed investment options for the Windpower

Economic Benefit funds. Steve Errebo moved to approve Orders of Cancellation, whereby the Board of Commissioners of Lincoln County, Kansas, do hereby order cancellation of the following expense warrants: Midwest Community Bank warrant no. 21798, dated September 28, 2007, issued to Randy Rathbun in the amount of \$40.00 for reimbursement for the purchase of two rural directories for Barnard Rural Fire District; and Midwest Community Bank warrant no. 21451, dated July 31, 2007, issued to Les Richards in the amount of \$2.35 for reimbursement of turnpike tolls, seconded by Terry

Finch. Motion carried.

Culvert Request: Doug Budreau requested culvert repair in Elkhorn Township.

Highway Department: Road Supervisor Larry Meitler with Assistant Road Supervisor Michel O'Hare reported

on highway department activities. O'Hare discussed a request received to close a road allowing APAC Shears to mine rock from the road bed and then backfill the road. The board made no decision this date. O'Hare reported on changes that the State has made to the geological study requirements for State bridge projects. O'Hare approved cost estimates to add accessories to the newly acquired Mack truck. The board approved

adding accessories to the truck with a cost not to exceed \$20,000.00.

Health Department: Health Nurse/Administrator Ladonna Reinert discussed client service funding through

the Older Americans Act and Senior Care Act and how funding cuts will affect clients

and the health department.

LEPP Programs: Shawn Esterl, Saline County Health Department provided quarterly reports for the

Local Environmental Protection Program (LEPP). Esterl provided information on

services being provided by the Health Department.

Culvert Request: Norman Mannel requested culvert repair in Valley Township.
