Call to Order:	March 1, 2010 The regular meeting of the Lincoln County Board of Commissioners was held in the commission meeting room of the courthouse Monday, March 1, 2010. Chairman Al Joe Wallace called the meeting to order at 10:00 a.m. with Vice-Chairman Terry Finch and Member Steve Errebo present. County Clerk Dawn Harlow was in attendance, with Debora Zachgo acting as recording secretary during portions of the meeting.

Ambulance Service:	Ambulance Service Director Wendy Gronau discussed the recent annual inspection conducted by the State Board of EMS and the inspection process, noting that only one deficiency was cited and that it has been corrected, providing a copy of the letter sent to the State notating the correction. Gronau related that the Lincoln Sentinel is producing a health care issue and discussed advertising options. The board approved printing an eighth page ad. Gronau discussed ambulance activities.
