Health Department: Health Nurse Administrator Ladonna Reinert presented a WIC contract for the board's

approval. Al Joe Wallace moved to enter into a contract between the Kansas Department of Health and Environment and the Lincoln County Health Department to provide special supplemental nutrition program for Women, Infants and Children

(WIC), seconded by Steve Errebo. Motion carried.

County Treasurer: County Treasurer Joyce Walker presented one Order of Cancellation for the board's

approval. Walker detailed plans to advertise Treasurer's Office closings for motor vehicle customers that will occur while converting to the new DMV system in December.
