County Treasurer: County Treasurer Joyce Walker presented a comparison of sales tax received from

2003-2010 and the following 4<sup>th</sup> quarter 2010 reports for the board to review: Treasurer's Quarterly Idle Funds Investment Report interest earned - \$19,989.20; and the Treasurer's Special Vehicle Fund Report with a 12-31-10 fund balance of

Terry Finch presented the WEB Fund committee recommendations for the board's After reviewing, Al Joe Wallace moved to approve the WEB Fund Committee's recommendations as presented and approved the following Windpower Economic Benefit fund distributions: Lincoln County Economic Development Foundation, \$18,000, to help provide loan resources for a small business; The Bud Finch Memorial Community Theatre Foundation, \$10,000, to partially repay the loan secured for the digital equipment upgrade to the Economic Development Foundation; Sylvan Unified Schools, USD 299, \$9,000, as matching funds to help the school district purchase a new portable laptop computer lab for the high school; and Lincoln County Hospital and Health Care Foundation, \$8,000, to purchase two Electronic Vitals

Documentation Systems, seconded by Steve Errebo. Motion carried.

Nursing Home: Nursing Home Administrator Christen Robinson answered questions about Hospice

Care in Lincoln County. The board approved the installation of a grease trap from

R&R-Street Plumbing in the amount of \$6,100.00.
