Call to Order:	February 11, 2008 The regular meeting of the Lincoln County Board of Commissioners was held in the commission meeting room of the courthouse Monday, February 11, 2008. Chairman Terry Finch called the meeting to order at 10:00 a.m. with Vice-Chairman Steve Errebo and Member Al Joe Wallace present. County Clerk Dawn Harlow was in attendance.
Visitors:	Others present for portions of the meeting: Doug McKinney, Wendy Gronau, Larry Meitler, Michel O'Hare, Rodney Job, Ladonna Reinert, Judy Larsen and Perry West.
Sylvan Grove Fire Grant Application:	Doug McKinney, North Central Regional Planning Commission provided information on the Sylvan Grove Rural Fire District grant application.
Ambulance Service:	Ambulance Service Director Wendy Gronau reported on ambulance service activities.
Highway Department	Road Supervisor Larry Meitler detailed highway department projects being completed. The group discussed contracting fuel for the summer. Assistant Road Supervisor Michel O'Hare presented a letter to Tradewind Energy, concerning the use of existing entrances on Colt Dr. The board approved the submission of the letter by the highway department. O'Hare reported that road relocation plans had been delivered to affected landowners along Jaguar Dr for their review. O'Hare provided cost estimates to replace the shop truck, no decision made this date. O'Hare related a long list of FEMA requirements in handling debris from the December ice storm and questioned the feasibility of trying to meet FEMA requirements.
