## **COMMISSIONER PROCEEDINGS**

Call to Order: The regular meeting of the Lincoln County Board of Commissioners was held in the

commission meeting room of the courthouse Tuesday, July 5, 2011. Chairman Terry Finch called the meeting to order at 8:05 a.m. with Vice-Chairman Steve Errebo and Member Al Joe Wallace present. Debora Zachgo served as recording secretary in the

absence of County Clerk Dawn Harlow.

Visitors: Others present for portions of the meeting: Michel O'Hare, Russ Black, Les Richards,

Theresa Richards and Jennifer O'Hare.

Beverly RFD: Debora Zachgo forwarded a request from Beverly Rural Fire asking for approval to pay

for the purchase of a new fire truck with mid-month accounts payable. The board

approved the request.

Highway Department: Assistant Road Supervisor Michel O'Hare reported on highway department projects.

O'Hare provided a list of damages from the recent flood following the review with FEMA, who will determine if Lincoln County meets the threshold to qualify for disaster relief assistance. O'Hare provided a bid from Hi-Plains Sand, Inc to chip seal 14 miles

of road and to patch oil roads. After discussion, Al Joe Wallace moved to enter into a contract with Hi-Plains Sand, Inc to chip seal 14 miles of road at a cost of \$303,564.80

and to patch oiled roads at a cost of approximately \$6,000.00, with funds being drawn from the Road & Bridge general operating budget, seconded by Steve Errebo. Motion

Carried. The board, acting as Selection Committee for Bridge Projects 53C-4531-01 and 53C-4532-01, reviewed and evaluated firms contacted to provide construction engineering services. The board, acting as Negotiating Committee, ranked consultants

according to selection committee findings. Al Joe Wallace moved to select Schwab-Eaton, P.A. to provide construction engineering services for Bridge Projects 53C-4531-01 and 53C-4532-01 and to approve the chairman signing the following forms:

Consultant Evaluation by Selection Committee (Attachment 8) and Ranking of Consultants by Negotiating Committee (Attachment 9), as presented, seconded by Steve

Errebo. Motion carried.
