H1N1 Update:	The board reviewed an H1N1 update prepared and provided by Health Nurse/Administrator Ladonna Reinert.
LEPC:	Commissioner Errebo reported on the recent LEPC meeting that he attended.
Lawn Use Request Approved:	Clerk Harlow forwarded a request from the Lincoln Area Chamber of Commerce to utilize courthouse grounds for the pumpkin decorating contest on October 30. The board approved the request.
Extended Illness Approved:	County Appraiser Rhonda Wright requested approval to utilize extended illness leave sporadically to care for a family member. The board approved the request.
Economic Development:	Economic Development Director Stanley Walker presented a proposal to borrow money from the Windpower Economic Benefit fund for the purpose of providing matching funds to obtain a Rural Business Enterprise Grant to enlarge is existing revolving loan program. Walker related that the Farmway COOP plans to apply for an economic development tax abatement for the their new storage facility owned by Farmway Storage #1 LLC and provided a comparison of tax savings between the economic development tax abatement and the neighborhood revitalization tax rebate program.
12 th Judicial District Community Corrections:	Ellen Anderson, 12 th Judicial District Field Services Director presented the 12 th Judicial District Community Corrections Year-End Outcomes for Fiscal Year 2009 for the board's approval. Nursing Home:	Greg Babcock presented bids received to replace windows at the nursing home. County Treasurer:	County Treasurer Joyce Walker provided current interest rates for certificates of deposit (CD) and asked the board for input in reinvesting an expiring Windpower Economic Benefit fund CD. Walker informed the board of her frustrations with the inability to get the local newspaper to print an article concerning changes in the vehicle registration process that will affect all motor vehicle owners in the future. Walker related that as part of the DMV Modernization Project the State now requires that anyone completing title and registration processing must provide their driver's license or FEIN (Federal Employer Identification Number) documents, further noting that the name on the title will appear exactly as it is on these documents to help ensure consistency.
Law Enforcement Employee Hired:	Undersheriff Les Richards requested approval to employ a part-time per-need deputy and recommended a starting wage of \$12.00 per hour. Terry Finch moved to employ Brian Kinnaird as a part-time per-need deputy, starting salary \$12.00 per hour, effective upon the successful completion of pre-employment testing, seconded by Al Joe Wallace. Motion carried.
Nursing Home:	Christen Robinson, Lincoln Park Manor, reported on nursing home activities.
