Call to Order: The regular meeting of the Lincoln County Board of Commissioners was held in the commission

meeting room of the courthouse Monday, October 5, 2020. Chairman Randy Lohmann called the meeting to order at 10:00 a.m. with Vice-Chairman James Gabelmann and Member Alexis

Pflugh present. County Clerk Dawn Harlow was in attendance as recording secretary.

Highway Department Commissioner Gabelmann related that the Wilson Funeral Home and Lenora Howe family

wished to thank the highway department for the work done to prepare the roads to the cemetery for the funeral. Director of Highway Department Brendan Mackay inquired whether the board planned for him to remain on the Homeland Security Council. The board related that they had appointed Baldwin Fisher to the council and thanked him for filling in during the interim. Mackay presented bids to purchase for a different style mower from KanEquip in the amount of \$21,800 and Howard's in the amount of \$14,500. Mackay provided the attendance sheet for the safety meeting that he held and reported that the berm on E Fox Dr has been removed. The group discussed personnel, training, who operates specific equipment, and vacating roads. The board discussed the request to trim trees that was made this summer and again in August. After discussion, the board determined a need to meet at the location to view the situation and approved placing a field trip on the agenda for October 12 at 1:00 p.m. Mackay requested that the board give consideration of increasing the amount of extended illness accrual for employees who work more than 40 hours per week. The board will complete Mackay's evaluation on Monday, October 12.
