Call to Order: The Lincoln County Board of Commissioners meeting was held in the courthouse commission

meeting room Monday, May 17, 2021. Chairman Randy Lohmann called the meeting to order at 8:30 a.m. with Vice-Chairman Dennis Ray and Member Darrell Oetting present. County Clerk

building)

Updates: Commissioner Ray notified the board of concerns regarding the bid for the CDBG Grant project

replacing three emergency warning sirens, including the location of the Vesper siren. Commissioner Ray has contacted the Vesper Mens Club regarding the possibility of installing the warning siren at that location and read the response. The board discussed the highway shop in Vesper as an alternative location. Commissioner Ray related that he had contacted Forrest Rhodes regarding the status of the EEOC complaint. Rhodes will meet with the board on May 24. Commissioner Ray reported that Steve Andreson replaced the starter in the recycling

center's forklift.

Transportation Bus: Transportation Bus Driver Roberta Turner provided information on the Mobility Manager's

request for funding and the proposed policy for transporting children. Turner related that KDOT has ordered that masks continue to be worn until September 15. Turner reported that a

Concealed Carry Policy needs to be included in the rider handbook.

Convention of States: Art Howell requested that the board support the Convention of States Article 5. The board took

no action this date. Howell updated the board on the importance of local government units

supporting the movement and answered the board's questions.
