Call to Order: The regular meeting of the Lincoln County Board of Commissioners was held in the

> commission meeting room of the courthouse Tuesday, September 8, 2015. Chairman Gerald Huehl called the meeting to order at 8:00 a.m. with Vice-Chairman Al Joe Wallace and Member Terry Finch present. County Clerk Dawn Harlow was in

attendance.

Emergency

Department:

Emergency Manager David Dohe with Health Nurse/Administrator Ladonna Reinert Management/ Health provided information received at an out-of-state Local Emergency Planning Committee (LEPC) conference that both attended, concerning Cyber Security and Tier II reporting inspections, to ensure that fire departments know the location of all chemicals reported. Reinert requested that the county department heads, or employees responsible for technology, meet with Nex-Tech officials to discuss the counties vulnerabilities, needs and services being provided. The board agreed that there is a need and related that it will be mandated that all department heads attend. Reinert will schedule the meeting with a tentative date of October 12.

Health Department:

Health Nurse/Administrator Reinert related that the health department has been handing out books to children through the age of 18, for many years and the cost of the books has been steadily increasing. Reinert related that the department qualifies for 400 free books, however they will have to pick up the books in Kansas City. Reinert requested approval to split the costs with an organization from Ellsworth County to drive to Kansas City to pick up both organizations' books. The board approved the request.

Highway Department: Director of Public Works Michel O'Hare with Road and Bridge Foreman Robert Howe reported on highway department projects. O'Hare presented a utility permit agreement for the board's approval. Al Joe Wallace moved to approve a utility permit agreement with Wilson Communications, seconded by Terry Finch. Motion carried. Howe provided information on bridge projects. O'Hare reported that the department was awarded the High Risk Rural Roads (HRRR) program grant, approving signage improvements for major collector routes on the west side of K-14 in 2016, east side in 2017 and minor collectors, no local roads, in 2018. Overall preliminary project cost is \$275,000. O'Hare related that the county also qualifies for grant funding to complete a Local Road Safety Plan, county's match would be 10% or an estimated \$4,000.

Human Resources: Human Resource Officer Debora Zachgo provided information on the Ambulance Ambulance Service Service Director. Al Joe Wallace moved to employ Susan Vavrik as the full-time

Ambulance Service Director, starting salary \$3,375 per month, effective upon successful completion of pre-employment testing, seconded by Terry Finch. Motion carried. The board discussed the fact that the newly hired Director's husband is also a paramedic and the need for additional paramedics in the county. Zachgo provided the current policy in regards to Employment of Relatives. After discussion, the board determined that due to the need for additional paramedics within the county that they

would like to consider amending the currently policy to allow Employment of Relatives on a part-time, no more than 1,000 hours per year basis. No action was taken this date.
