Steve Errebo moved to allow the chairman to sign a project agreement approving Amendment No 2 with US Department of Agriculture Natural Resources Conservation Service, seconded by Al Joe Wallace. Motion carried. The group reviewed an agreement for commercial drivers license. Steve Errebo moved to enter into an agreement for commercial drivers license with employee Kelvin Lopez,

seconded by Al Joe Wallace. Motion carried.

Resolution 2010-18: Steve Errebo moved to approve and adopt Resolution 2010-18, rescinding State of

Disaster Emergency Proclamation Resolution 2010-17, lifting the burn ban previously

enacted, seconded by Al Joe Wallace. Motion carried.

Draft Audit Report Steve Errebo moved to allow the chairman to sign the 2009 draft audit report provided
