Approved: application to the Kansas Community Service Tax Credit Program.

Ambulance Service: Ambulance Service Director Wendy Gronau reported that the department was approved

> for the Kansas Revolving and Assistance Fund (KRAF) Grant Program to purchase modules for two cardiac monitors. Gronau presented an employee's letter of resignation. Terry Finch moved to accept the resignation of Michael Dail, effective

Beverly Concern: Ralph Melton, Beverly City Council Member, issued concerns regarding a resident of

> Beverly setting off binary explosives outside of the city limits. Melton stated that the noise is disruptive to the Beverly residents and inquired if the County could assist with

resolving the situation.

Road Request: Steve McReynolds requested that the barricades on E Milo Dr be removed, as the

> barricades are not effective as drivers are driving in the ditch to get around them. The board related that they are considering the removal of one barricade at each end of the

pavement.

Highway Department: Director of Public Works Michel O'Hare and Road and Bridge Supervisor Robert Howe

presented a gravel agreement for the board's approval. Al Joe Wallace moved to enter into a two year gravel removal/purchase agreement with Jeremy Rosebrook and Holl Hill Ranch, expiring May 7, 2017, seconded by Terry Finch. Motion carried. O'Hare provided pricing estimates from Bruckner's to complete an engine overhaul. Discussion ensued regarding E Milo Dr and the fact that the road is seeing a significant increase in traffic flow due to the K-18 bridge closure. After discussion the board requested that one of the barricades be removed and that contact has been made with the KDOT in

regards to the situation.

Hillegeist as a temporary part-time per need CNA/HHA. Terry Finch moved to employ

Employee Hired: Jenny Hillegeist as a temporary part-time per-need CNA/HHA, starting salary \$10.50

per hour, effective April 20, 2015, seconded by Al Joe Wallace. Motion carried.
