Emergency Emergency Manager Rodney Job presented a proclamation for the board's approval. Management: Steve Errebo moved to proclaim October 3-9 as fire prevention week, seconded by

Highway Department: Road Supervisor Larry Meitler with Assistant Road Supervisor Michel O'Hare reported

on highway department projects. Monty Breneman discussed cost overruns on the Emergency Watershed Protection Programs and presented an amendment for the board's approval. Meitler related that the bridge tuckpointing projects were completed. Steve Errebo moved to approve Amendment 1 to the Project Agreement with the US Department of Agriculture Natural Resources Conservation Service, seconded by Terry Finch. Motion carried. Terry Finch moved to set term limits for the Commissioner appointed Windpower Economic Benefit Fund Board members as follows: Debora Ortiz expiring February 28, 2011, Tammy Rees expiring February 28, 2012, and Jason Dohl expiring February 28, 2013, seconded by Steve Errebo. Motion

carried.
