## **COMMISSIONER PROCEEDINGS**

April 1, 2013

Call to Order: The regular meeting of the Lincoln County Board of Commissioners was held in the

commission meeting room of the courthouse Monday, April 1, 2013. Chairman Al Joe Wallace called the meeting to order at 10:00 a.m. with Vice-Chairman Terry Finch and

Member Gerald Huehl present. County Clerk Dawn Harlow was in attendance.

Ambulance Service: Ambulance Service Director Wendy Gronau reported that the Board of EMS had

conducted an annual inspection of the department and explained deficiencies that were sited, noting that all have been corrected. Gronau discussed current rates being charged and related that she is working on obtaining current Medicare rates of reimbursement and will present adjusted rates at a later date. The group discussed the recent

KWORCC site inspection.

Payroll Approved: Terry Finch moved to approve gross payroll run in the amount of \$1,395.00, seconded

by Gerald Huehl. Motion carried.

Health Department: Health Department Office Manager Judy Larsen related that there was no price

difference in the copier if the department's current unit was traded in or kept. The board approved allowing the health department to purchase a copier without a trade in and that

the old unit will be given to another county department.

Law Enforcement: Sheriff Mike Weigel with Undersheriff Dustin Florence related that Clint Bailey has

completed his first six months of employment and requested the customary salary increase. Terry Finch moved to grant Clint Baily a fifty cent per hour merit increase for the completion of the first six months of employment, effective February 26, 2013, seconded by Gerald Huehl. Motion carried. The duo updated the board on law

enforcement activities.

Sign Request: David Dohe related that he witnessed a semi truck run a stop sign at an intersection in

Denmark. Dohe requested a Child at Play sign be placed prior to the stop sign to

encourage people to stop at the sign.

Purchase Approved: Pete Falcon answered questions concerning bids received to purchase a carpet cleaner,
