Call to Order:	November 14, 2022 The Lincoln County Board of Commissioners met in the courthouse commission meeting room Monday, November 14, 2022. Chairman Dennis Ray called the meeting to order at 8:30 a.m. with Vice-Chairman Darrell Oetting and Member Randy Lohmann present. County Clerk Dawn Harlow was in attendance as recording secretary.
Visitors:	Others present for portions of the meeting: Anthony Dail, Dale Hlad, Sarah Hageman, and Forrest Rhodes (via telephone).
Correspondence:	Correspondence: a letter from the City of Salina notifying that they will be increasing the tipping rate from \$42.00 to \$44.00 per ton beginning January 1, 2023; mid-month accounts payable; a letter from KWORCC regarding the Annual Meeting; bills for Lincoln Park Manor; WEB fund distribution recommendations; and a sealed bid to replace a boiler at Lincoln Park Manor.
Correspondence Action:	Randy Lohmann moved to approve the Lincoln County Windpower Economic Benefit Fund (WEB fund) grants: Vesper Community Mens Club \$2,643.26 (assist with the purchase and installation of a kitchen hood exhaust system); Bud Finch Memorial Theatre \$2,000 (assist with the deductible to replace roof); Lincoln Senior Center \$5,000 (assist with mold remediation); Lincoln County Economic Development Foundation \$2,000 (assist in improving the appearance of five storefronts in downtown Lincoln); Lincoln Emergency Planning Committee \$400 (to provide lunch for quarterly meetings); and City of Beverly \$600 (assist with the purchase of a new printer), for a total of \$12,643.26, seconded by Dennis Ray. Motion carried. The board tabled the sealed bid received from Street Plumbing to replace a boiler at Lincoln Park Manor. Randy Lohmann moved to approve the mid-month accounts payable in the amount of \$18,016.89, seconded by Darrell Oetting. Motion carried.
Recycling Center:	Commissioner Ray reported that he had contacted Hayworth Plumbing and Heating to service the Recycling Center's heaters and replace a faucet.
KOMA Training:	Commissioner Lohmann related that he had contacted Jay Hall with the Kansas Association of Counties regarding KOMA training and will be attending an online training in early December.
Minutes Approved:	Randy Lohmann moved to approve the edited minutes for November 7, 2022, seconded by Darrell Oetting. Motion carried.
Highway Department:	Director of Highway Department Dale Hlad presented a utility permit agreement for the board's approval. Dennis Ray moved to approve the utility permit agreement with Wilson Communications near Kiowa & 30 th , seconded by Randy Lohmann. Motion carried. Hlad provided a sales agreement to purchase a rebuilt 2008 140M Caterpillar motor grader for the board's consideration. Darrell Oetting moved to approve buying a completely rebuilt 2008 140M Caterpillar Motor grader for \$169,000 and trading in the burned-up motor grader, seconded by Randy Lohmann. Motion carried. Hlad reported that the State has confirmed that OS 19 and OS 178 are not considered bridge length and will not need to be inspected in the future. Hlad related that after inspection, it was recommended to close OS 40, as the bridge deck has holes in the concrete. OS 40 is located on a dirt road over the Rattle Snake Creek. The board approved moving forward with closing the bridge.
