## COMMISSIONER PROCEEDINGS

December 30, 2013

Call to Order: The regular meeting of the Lincoln County Board of Commissioners was held in the

commission meeting room of the courthouse Monday, December 30, 2013. Chairman Al Joe Wallace called the meeting to order at 8:00 a.m. with Vice-Chairman Terry Finch and Member Gerald Huehl present. County Clerk Dawn Harlow was in

attendance.

County Attorney: County Attorney Jennifer O'Hare, presented Resolution 2013-22 addressing Violence

> and Weapons in the Workplace and the proposed Security Plan for the courtroom while court is in session, due to last year's state legislation which allows concealed carry

handguns into county owned buildings.

**Budget Hearing:** Chairman Wallace convened the scheduled budget hearing at 10:15 a.m., for the

> purpose of hearing and answering objections of taxpayers relating to the proposed amended use of budgeted funds with Jennifer O'Hare, Steve McReynolds, Tim Meier and Wendy Gronau present for portions of the hearing. With no others appearing, the chairman adjourned the budget hearing at 10:45 a.m. and convened the meeting to

regular session.

Budget Amendments Terry Finch moved to approve and adopt the following 2013 budget amendments: amend the County General Fund in the amount of \$35,000; amend the Ambulance Fund \$25,000; amend the Employee Benefits Fund in the amount of \$10,000; and amend the Noxious Weed Fund in the amount of \$3,000, seconded by Gerald Huehl. Motion

carried.

Steve McReynolds with Tim Meier inquired as to why the county could not financially Development: assist or even provide health insurance benefits for the Lincoln County Economic

> Development Foundation, and what could be done to increase the mill levy. Board members related that the Foundation is a not-for-profit foundation and that it is not a county entity so therefore employees are not county employees; and that the foundation's mill levy was levied based upon an election for a maximum of two mills,

so any future mill levy increase must be voted on.

Ambulance Service: Ambulance Service Director Wendy Gronau provided cost estimates to program other

> counties 800 MHz frequencies into the Service's 800 MHz radios so that when responding for mutual aid the agencies will be able to communicate. The board tabled a

decision until the new budget year.

employee regulations for Violence and Weapons in the Workplace and as well as

incorporating a Security Plan for the courtroom, seconded by Terry Finch. Motion carried.

deficiencies.

Highway Department: Road Supervisor Larry Meitler with Assistant Road Supervisor Michel O'Hare reported

on highway department activities and equipment. Meitler presented a gravel Gravel Agreement: removal/purchase agreement for the board's approval. Terry Finch moved to enter into

a two-year gravel removal/purchase agreement with Block Family Ventures, expiring

December 30, 2015, seconded by Gerald Huehl. Motion carried.
