Call to Order:	April 30, 2021 The Lincoln County Board of Commissioners met in the courthouse commission meeting room Friday, April 30, 2021. Chairman Randy Lohmann called the meeting to order at 11:00 a.m. with Vice-Chairman Dennis Ray and Member Darrell Oetting present. County Clerk Dawn Harlow was in attendance as recording secretary.
Visitors:	Others present for portions of the meeting: Sarah Hageman.
Accounts Payable & Payroll Approved:	Dennis Ray moved to approve accounts payable in the amount of \$359,927.73, seconded by Darrell Oetting. Motion carried. Randy Lohmann moved to approve the payroll for April in the amount of \$198,441.47, seconded by Dennis Ray. Motion carried.
Correspondence:	Correspondence: A letter from Kathy Moss resigning from the Lincoln County Council on Aging; and a letter from Jeannie Friess resigning from the Lincoln County Council on Aging.
Bids Awarded:	The board opened the sealed bids received to purchase and remove the Façade and Budweiser sign from 128 W Lincoln Ave and 132 W Lincoln Ave. Randy Lohmann moved to take the bids from Sean Peterson for \$500 for the façade and \$500 for Budweiser sign and give sixty thirty days to remove, seconded Dennis Ray. Motion carried.
Courthouse Studies:	Clerk Harlow provided the contract from Kirkham Michael to complete the site survey of the courthouse. Clerk Harlow provided the bid and contract from GSI Engineering to complete the environmental study of the courthouse.
