Emergency Emergency Manager Rodney Job reported on the fire in the Northwest part of Lincoln

Management: County that required a State of Local Disaster Emergency for Lincoln County

Resolution 2009-10: Terry Finch moved to approve and adopt Resolution 2009-10, rescinding Resolution

2009-09 declaring a State of Local Disaster Emergency Proclamation for Lincoln

County dated April 3, 2009, seconded by Al Joe Wallace. Motion carried.

Rescue Truck: Michel O'Hare reported that the 1998 Freightliner Rescue Truck was delivered and

appears to be in good shape with only minor repairs needing to be made.

Highway Department: Assistant Road Supervisor Michel O'Hare reported on highway department projects and

equipment. O'Hare presented an Agreement for Engineering Services with Schwab-Eaton P.A. for the board's approval. Al Joe Wallace moved to approve entering into an Agreement for Engineering Services for Federal Aid Project to complete a preliminary field survey and grading plans for KDOT letting of the N 280<sup>th</sup> Rd landslide project, seconded by Terry Finch. Motion carried. The board commended O'Hare for his work on the grant applications for the transportation enhancement federal stimulus funds.

O'Hare discussed the State's railroad signage project and county gravel pits.
