Hospital: Hospital Board of Trustees Chairman Stanley Crawford with Hospital Administrator

> Greg McNeil updated the board on the hospital renovation project. Crawford related that the hospital has the opportunity to purchase the W1/2 of the lots previously purchased for the Sylvan Grove Medical Clinic and inquired if the county would be able to assist with clearing the lots if the hospital purchased them. The board related that they would visit with the highway department supervisors prior to making a decision. McNeil invited the board to attend a barbeque at the hospital on May 12 for National
