Community Ellen Anderson, 12th Judicial District, presented grant documentation for signatory Corrections:

Ambulance Service: Ambulance Service Director Wendy Groanu demonstrated one of the three tablets

received from Region IV EMS. Gronau reported that the service was awarded a KRAF grant to purchase a cardiac monitor, noting that the county's cost share is \$6,300. The group discussed adding part-time ambulance attendants and requirements that will be required to ensure that the county conforms with the Fair Labor Standards Act (FLSA).

County Treasurer: Deputy County Treasurer Leann Bishop presented a bid from File Safe to purchase two

Time-2 Speed File systems with accessories in the amount of \$10,125. The board approved the purchase with payment in equal shares from the Capital Improvement Fund and the Treasurer's Special Vehicle Fund. Bishop provided the following 1st quarter 2012 Treasurer Quarterly reports: Treasurers Special Vehicle Fund Balance –

\$11,028.82; and Interest Earned on Idle Funds - \$9,405.83.
