USD 298: USD 298 Superintendent Kathy Robertson and District Treasurer Nancy Knapp related that the

> school district has been approached regarding the district asking for an advancement on the windpower economic benefit money as a way to fund needed repairs at the school as well as the loss of revenue from state aid. The board related that an advancement will not be an

option.

CKMHC Budget Request:

Kathy Mosher and Pat Kinnard, Central Kansas Mental Health Center, detailed CKMHC's activities and programs offered Lincoln County citizens. Mosher presented the Center's 2018 budget request of \$16,643, an increase of \$297 over the amount received for the 2017 budget year. Mosher was requested to provide Lincoln County statistics for use of the program.

Highway Department:

Director of Public Works Michel O'Hare with Road and Bridge Supervisor Michel O'Hare and Emergency Manager David Dohe reported on damages sustained during the April 15 storm that caused flash flooding. Dohe presented an emergency declaration proclamation for the board's approval. Alexis Pflugh moved to approve and adopt Resolution 2017-11, proclaiming a State of Local Disaster Emergency for Lincoln County, Kansas, effective for seven days, seconded by Terry Finch. Motion carried. O'Hare related that he has not received an expected delivery date for the two recently purchased John Deere motor graders; and that the equipment has been delivered to the landfill to begin crushing the concrete pile. The group discussed Steve Schneider's request for road improvement. Howe forwarded a request from Kinder Morgan to allow them to rock a portion on N 160th Rd. After discussion, Terry Finch moved to allow Kinder Morgan to rock a portion of N 160th Rd, with the stipulation that the county will not provide future repairs to the improved road, seconded by Alexis Pflugh. Motion carried.

DVACK:

Karen Larsen, DVACK, provided information about the Domestic Violence Association of Central Kansas and read the Sexual Assault Awareness Month Proclamation, requesting that the board consider Proclaiming the month of April 2017 as Sexual Assault Awareness Month. Terry Finch moved to proclaim April 2017 as Sexual Assault Awareness Month and pledges to join advocates and communities across the country in playing an active role to prevent sexual violence, seconded by Alexis Pflugh. Motion carried.

Recess:

The chairman recessed the meeting for lunch at 12:07 p.m.

Reconvene:

The chairman reconvened the meeting to regular session at 1:00 p.m.

Nursing Home Proposal: John Grace and Mark Mingenback, Kansas Senior Living (KSL) with Christen Robinson, Lincoln Park Manor presented a proposal in which Kansas Senior Living would build four GreenHouses, with the county making a substantial match donation towards the project as well as pay for remodeling the current nursing home facility, noting that the county would retain ownership in the current facility, but KSL would pay for all future upkeep and repairs after the remodeling is complete. No decision was made this date.

Economic Development: Economic Development Director Kelly Larson related that the cost to lease one of the billboard's along I-70 will increase and inquired if the board would like to continue leasing the billboard, noting that currently the County, City of Lincoln and the Economic Development Foundation share in the total annual cost for both signs. Terry Finch moved to continue to share in the cost to lease two billboards along I-70 from Thoms Outdoor Advertising, in the amount of \$600 per year, seconded by Al Joe Wallace. Motion carried.

Meeting Time Change Approved:

The board approved returning to the 8:00 a.m. - 12 noon summer commission meeting schedule beginning May 1.

Minutes Approved: Al Joe Wallace moved to approve and adopt the minutes of the April 10, 2017 regular meeting
