COMMISSIONER PROCEEDINGS

April 28, 2008

Call to Order: The regular meeting of the Lincoln County Board of Commissioners was held in the

commission meeting room of the courthouse Monday, April 28, 2008. Chairman Terry Finch called the meeting to order at 10:00 a.m. with Vice-Chairman Steve Errebo and

Member Al Joe Wallace present. County Clerk Dawn Harlow was in attendance.

Visitors: Others present for portions of the meeting: Rodney Job, Larry Meilter, John Cashatt,

Michel O'Hare and James Warta.

Billing: Clerk Harlow provided a billing from Susan Marshall. The board requested that the bill

be forwarded to the County Attorney.

Emerg. Management: Emergency Manager Rodney Job reported on emergency management activities.

Apache Rd Landslide: John Cashatt, Schwab Eaton, P.A. reviewed the two bids received to repair the Apache

Ln road slide and discussed the price variance between the two bids. The group discussed the West Elkhorn Creek Bridge Project, Cashatt related that the dirt

contractor struck a rural water line noting that the line might have to be relocated.

Highway Department: Road Supervisor Larry Meitler reported on highway department projects. Assistant

Road Supervisor Michel O'Hare provided information on three bridges needing tuck pointing. The group decided to let the bridge work as one project, with the option to remove one of the smaller bridges if the bids received are more than the amount budgeted for the project. Meitler and O'Hare related that due to personnel shortages that they would like the board to consider contracting with individuals or businesses to haul gravel and complete projects for the highway department; the board requested cost estimates to determine the feasibility. O'Hare reported that he attended a two day training course for the rescue squad and requested that the board not require him to use

leave time during his absence. The board denied the request.

Reconvene: The chairman reconvened the meeting to regular session at 1:22 p.m.

Warta requested that the board not vacate approximately 200 yards of the proposed road vacation lying between Section 36 Golden Belt Township and Section 31 Valley Township as he uses it as a pasture access.
