Call to Order: The regular meeting of the Lincoln County Board of Commissioners was held in the

commission meeting room of the courthouse Monday, August 4, 2008. Chairman Terry Finch called the meeting to order at 8:00 a.m. with Vice-Chairman Steve Errebo and

Member Al Joe Wallace present. County Clerk Dawn Harlow was in attendance.

Landfill/Transfer

Trailer Purchase

Approved:

Landfill/Transfer Station Operator Carrie Meili presented price quotations to repair and/or replace the transfer trailer. After discussion, Al Joe Wallace moved to purchase a 2009 Wilkens lite-weight aluminum opentop transfer trailer from Wilkens Industries, total purchase price with trade-in allowance \$49,420.00, seconded by Steve Errebo. Motion carried. Meili presented proposed rate increases for waste tire disposal fees, to match that currently being charged by the tire recycler. Meili discussed the white goods contract; apron repair status; and requested that the landfill be closed the Saturday of Labor Day Weekend. The board approved closing the landfill on Saturday, August 30 in observance of Labor Day.

Emergency

Management:

Emergency Manager Rodney Job reported on a meeting attended concerning the legal ramifications for entities who claim to be NIMS (National Incident Management System) compliant and are not following the NIMS plan. Job discussed operations of the department and a need to have an assistant available when he is not.

Highway Department: Road Supervisor Larry Meitler with Assistant Road Supervisor Michel O'Hare reported on current and future highway department projects; updated the board on the progress of the West Elkhorn Creek Bridge replacement project; and discussed equipment.

Rural Arts Partners:

David Wiggins and Chris Cardwell, Rural Arts Partners, gave a PowerPoint presentation on the Rural Arts Partners and the programs that they are bringing into rural communities, some of which include: artists, musical artists and groups, and performance artists. The group requested that the County become a Rural Arts Partner by providing funding at certain levels or by advertising in the event brochures. Board members indicated their approval and support for the program but related that funding is not currently available, however they encouraged the group to apply for funding from the Windpower Economic Benefit fund when funds become available for applicants.

Economic Development: Economic Development Director Stanley Walker provided a sample of the new billboard covers that will be installed on the two billboards located on I-70. Walker provided information on plans to expand to additional billboards at key locations, indicating that participating employers will share in the cost of the billboards. Walker related that a job fair will be held during the Fall Festival.

Resolution 2008-13: Al Joe Wallace moved to approve and adopt Resolution 2008-13, establishing the fees to dispose waste tires at the Lincoln County Landfill/Transfer Station and rescinding Resolution 2004-21, effective August 4, 2008, seconded by Steve Errebo. Motion carried.
