September 14, 2009

Call to Order: The regular meeting of the Lincoln County Board of Commissioners was held in the

commission meeting room of the courthouse Monday, September 14, 2009. Chairman Steve Errebo called the meeting to order at 8:00 a.m. with Vice-Chairman Al Joe Wallace and Member Terry Finch present. County Clerk Dawn Harlow was in

attendance.

H1N1 Update: Health Nurse/Administrator Ladonna Reinert and Emergency Manager Rodney Job

updated the board on H1N1 flu activities.

Health Department: Health Nurse/Administrator Reinert presented several contracts for the Special

Supplemental Nutrition Program for Women, Infants and Children (WIC) program. Al Joe Wallace moved to authorize Chairman Steve Errebo to sign a contract between the Secretary of Health and Environment of Kansas and the Lincoln County Health Department, to conduct the Special Supplemental Nutrition Program for Women, Infants and Children in Lincoln, Ellsworth, Jewell, Mitchell and Ottawa Counties; and to enter into separate Agreements for Administrative Cooperation with Ellsworth, Jewell, Mitchell and Ottawa Counties to service as Local Agency for WIC programs

within their respective counties, seconded by Terry Finch. Motion carried.

Emergency Mngmt: Emergency Manager Job updated the board on emergency management activities.

County Treasurer: County Treasurer Joyce Walker discussed the 2009 budget, and provided a listing of

twenty properties eligible for delinquent property tax sale totaling \$31,615.86. Walker presented a Resolution for the board's consideration, which will allow the County Treasurer to no longer issue or provide reimbursement for overpayments of less than

\$5.00. The board made no decision this date.

Highway Department: Road Supervisor Larry Meitler with Assistant Road Supervisor Michel O'Hare reported

on highway department projects. The group reviewed results of the road flagging safety class that employees took on August 27. O'Hare related that they have discovered popcorn rock in one of the County leased gravel pits and provided cost estimates to mine the rock from the pit at approximately \$4,000.00. The board approved the additional expense to mine the rock. O'Hare provided a Code of Conduct form for Bridge Project 53C-4260-01 for the board's approval. Terry Finch moved to allow the chairman to sign the Code of Conduct form (Attachment No. 7) as presented, seconded by Al Joe Wallace. Motion carried. O'Hare discussed projects that will be repaired with funds from NRCS's Emergency Watershed Protection (EWP) Program, the program's required matching funds, and types of services that the County can provide

as in-kind towards the matching fund requirement.
