Chairman Al Joe Wallace called the meeting to order at 8:00 a.m. with Vice-Chairman Terry Finch and Member Steve Errebo present. County Clerk Dawn Harlow was in attendance.

Emergency Management: Resolution 2010-10:	Emergency Manager Rodney Job discussed department activities. Job related that the Mitigation Plan is complete and requested that the board approve a Resolution adopting the plan. Biennial Bridge Inspection & Landfil Mapping:	John Cashatt, Schwab-Eaton P.A. presented a proposal for the Biennial Bridge Il Inspection and explained the reasoning for the dramatic cost increase. Cashatt discussed the State's mapping requirements for the landfill/transfer station and shared that other counties are not complying with the mapping requirements. After discussion, the board determined not to complete mapping at this time see if the State will change its requirements saving the County approximately \$5,000.
