Highway Department	Road Supervisor Larry Meitler with Assistant Road Supervisor Michel O'Hare reported on highway department projects. Meitler provided a cost estimate for a 1976 John Deere 4430 tractor. After discussion, Steve Errebo moved to purchase a 1976 John Deere 4430 tractor from C & W Farm Supply in the amount of \$14,000., seconded by Al Joe Wallace. Motion carried.
