Call to Order:	August 16, 2010 The regular meeting of the Lincoln County Board of Commissioners was held in the commission meeting room of the courthouse Monday, August 16, 2010. Chairman Al Joe Wallace called the meeting to order at 8:00 a.m. with Vice-Chairman Terry Finch and Member Steve Errebo present. County Clerk Dawn Harlow was in attendance.

Sealed Bid Process:	Richard Schultz expressed his dissatisfaction with the sealed bid process on the old bulk fuel facility, specifically that his sealed bid opened in August 2009 has not been accepted or rejected.
Rec Commission Update:	Lincoln Recreation Commission Director Mindy Wiebke reviewed rec department activities.
Highway Department	^{1:} Road Supervisor Larry Meitler with Assistant Road Supervisor Michel O'Hare reviewed current highway department projects; and noted that bridge replacement project 53C-4260-01, Tromble Bridge, is open for traffic. Meitler reported that he purchased a skid steer blade for \$2500.00. O'Hare provided proposals to complete geotechnical engineering services for the board's approval. Terry Finch moved to enter into an agreement with GeoSource to complete geotechnical engineering services for Bridge Project 53C-4531-01 in the amount of \$5,890.00 and Bridge Project 53C-4532-01 in the amount of \$6,250.00, seconded by Steve Errebo. Motion carried. O'Hare requested approval to attend an out of state conference September 29 & 30. The board approved the request.
Final Performance Hearing/CDBG Grant Project 08-PF-617:	The chairman convened the scheduled final performance public hearing at 10:05 a.m. to review activities related to the recently completed CDBG Grant Project 08-PF-617, Sylvan Grove Rural Fire District Fire Station Project with Lori Thielen and Norman Mannel present. With no others appearing Steve Errebo moved to close the public hearing at 10:10 a.m. and allow the chairman to sign all grant closeout documentation for CDBG Grant Project 08-PF-617, Sylvan Grove Rural Fire District Fire Station Project as presented, seconded by Terry Finch. Motion carried.
Inquiry:	Norman Mannel inquired about the County's policy in regards to musk thistle complaints and mowing county road right-of-way.
Rescue Squad Radio:	Debora Zachgo forwarded a request from Lowell Vonada concerning a radio in one of the rescue squad trucks. The board approved replacing the radio.

The board identified revenues shortfalls and requested that all departments look at the 2010 estimated expenditures and make adjustments as necessary to ensure adequate funding for the 2011 budget; and related that all departments who charge a fee for services should review their current rate schedule.

Motion carried.
