COMMISSIONER PROCEEDINGS

Call to Order:	January 19, 2016 The regular meeting of the Lincoln County Board of Commissioners was held in the commission meeting room of the courthouse Tuesday, January 19, 2016. Chairman Al Joe Wallace called the meeting to order at 10:00 a.m. with Vice-Chairman Terry Finch and Member Gerald Huehl present. County Clerk Dawn Harlow was in attendance.
Visitors:	Others present for portions of the meeting: Stephanie Errebo, Kelly Larson, Steve McReynolds, Leann Bishop, Mitch Obermueller, Mike Weigel, Dustin Florence, Michel O'Hare, Robert Howe, Leann Bishop and Debora Zachgo.
Solid Waste Fee for Businesses:	Stephanie Errebo inquired about the solid waste disposal fee assessed to two businesses operated at 101 N Main in Sylvan Grove. Errebo related that it was unfair to bill both businesses as they are located in the same building and that other businesses with similar circumstances are not being billed, citing several business names as examples. Errebo complained about perceived inefficiencies by county departments in gathering information on new businesses. The board related that if each business is producing solid waste then each business will be assessed the solid waste disposal fee, and that other businesses Errebo cited will be reviewed.
Resignation Accepted	: Mitch Obermueller presented a letter of resignation from the Lincoln County Hospital Board of Trustees. The board approved the resignation.
Law Enforcement:	Sheriff Mike Weigel with Undersheriff Dustin Florence provided bids to replace the washer and dryer at the law enforcement center. Weigel requested approval for Zach McClure to park the patrol car in Tescott on weekends while he is attending the law enforcement academy. The board approved the request.
Highway Department:	Director of Public Works Michel O'Hare with Road and Bridge Supervisor Robert Howe reported on highway department projects and equipment. O'Hare forwarded road improvement requests from Nathan McCosh and Michael Kraus. O'Hare provided a map of the Kobbeman bridge replacement project and discussed easements needed.
