November 28, 2016

Call to Order: The regular meeting of the Lincoln County Board of Commissioners was held in the

commission meeting room of the courthouse Monday, November 28, 2016. Chairman Al Joe Wallace called the meeting to order at 8:00 a.m. with Vice-Chairman Terry Finch and Member

Gerald Huehl present. County Clerk Dawn Harlow was in attendance.

Beverly RFD: Jeff White and Dennis Ray, Beverly Rural Fire District requested approval to enter into a lease

purchase agreement with the Wilson State Bank. After discussion, Terry Finch moved to approve Beverly Rural Fire District entering into a three-year lease purchase agreement with the Wilson State Bank, to purchase and install firefighting equipment for a fire truck, and authorize County Clerk Harlow to sign all legal documentation, seconded by Gerald Huehl. Motion carried. The group discussed the current rate being reimbursed to volunteer firefighters and inquired if the amount could be increased for their fire district as the fire board has previously approved an increase to \$10 per hour for fire runs. The board related that further information will need to be determined as the income might become taxable to

the firefighters.

concerning the proposed vacation of several roads located in Grant Township. With no one appearing the chairman adjourned the road vacation hearing at 10:40 a.m. Gerald Huehl moved to approve and adopt the following: Final Resolution and Order Resolution 2016V-01, whereby it is therefore ordered that the following described county road, located in Grant Township, shall be vacated and is hereby vacated: That part of E Navajo Dr between Section 30 and Section 31, Township 11S, Range 9W beginning at the northeast corner of Section 31 also being the southwest corner of Section 30 thence west to the northwest corner of Section 31 also being the southwest corner of Section 30, said right-of-way being 60 feet, seconded by

Al Joe Wallace. Motion carried.
