Sheriff Mike Weigel and Undersheriff Dustin Florence discussed liability issues and

Shooting Range: concerns with the department's current practice of utilizing a shooting range on private property. Discussion was held regarding options to update and secure the former

shooting range at the landfill.

Motion Carried. Bids for the purchase of a new mower tractor were reviewed; no decision was made. Meitler will contact local banks regarding financing for the purchase of both the motor grader and mower tractor. Meitler reported that Coughlin Company may go over the approved tonnage amount of finished material. Meitler explained that if the unused oil is not utilized the County will

be charged for return freight.
